BMG Fundo de Investimento em Direitos Creditórios - Créditos Consignados VI: rating retirado. A última ação de rating ocorreu em 30 de março de 2009, quando os ratings foram rebaixados para Ba1 de Baa3 (Escala Global, Moeda Local) e para Aa2.br de Aaa.br (Escala Nacional Brasileira).
